In the circumstances reported by the Director, MDM & School Sanitation, Amaravati in the reference cited and after careful examination of the matter, Government hereby approve the following guidelines for Engagement of Sanitary Workers in Schools as proposed by the Director, MDM & School Sanitation.

- a. The Sanitary Worker will be appointed by the Head Master/Head Mistress in consultation with the Parent Committee for each School.
- b. The sanitary workers has to be engaged as per the following required strength on the Blocks, Urinals etc which are to be taken in to consideration:

Students/Blocks	No. of Sanitary workers to be engaged
Up to 100 students	1
101 to 500	2
500 to 1000	3
Above 1000	4

- c. An amount of Rs.5000/- P.M to be paid to the Sanitary Worker as Honorarium towards attending sanitary work and any other work entrusted by the Head Master/ Head Mistress concerned.
- d. Ammovadi amount shall be used to meet the honorarium by passing a resolution by HM and parents committee. Proper registers shall be maintained with all transactions.
- 2. Further, the Director, MDM & School Sanitation, Amaravati is informed that since it is proposed to allot money from the parent committee resolutions CMO may be kept informed about the procedures and if required SOP may be prepared detailing the issues involved like tools ,consumables,cleaning schedules etc.
- 3. The Director, MDM & School Sanitation, Amaravati shall take necessary action in the matter accordingly.

While enclosing the copy of reference 4th cited, It is informed to all the District Educational Offices that the Government has approved the following guidelines for engagement of Sanitary Workers in Schools

a..The Sanitary Worker will be appointed by the Head Master/Mistress with approval of resolution passed with the Parent Committee for each School.

b. The Sanitary Workers have to be engaged as per the following required strength on the Blocks, Urninals etc. which are to be taken into consideration

Students/Blocks	No.of Sanitary workers to be engaged
Up to 100 students	1
101 to 500	2
500 to 1000	3
Above 1000	4

c.An amount of Rs.5000/- P.M to be paid to the Sanitary Worker as Honorarium

towards attending sanitary work and any work entrusted by the Head Master/Mistress concerned.

d.Ammovadi amount shall be used to meet the honorarium by passing a resolution by HM and parents committee and proper registers shall be maintained with all transactions.

Therefore, all the Regional Joint Directors of School Education and District Educational Officers in the State are requested to follow the above guidelines scrupulously specified by the Government while engaging the sanitary workers in the School and proper records/registers formats for Ammavodi Donation amount, expenditure etc.. (already registers communicated) should be maintained with all transactions without fail, if any deviation in this regard will be viewed seriously and appropriate action will be taken on the concerned.

Further, they are also requested to issue necessary instructions to the filed functionaries on the above guidelines, on encouragement of donor on sanitation.

In continuation of the 5^{th} and 6^{th} cited, all the District Educational Officers in the state are requested to take the necessary following steps on the engagement of Sanitary Workers.

a) The parents committees shall engage the sanitary workers on outsourcing of service basis, based on the students' strength as mentioned in the above references. Parents Committee shall pass the resolution and record the minutes in registers.

b) The remuneration is to be given as per the reference given above by utilizing the donations made out of Ammovadi scheme. For paying remuneration of sanitary workers in each month, the Parents Committee shall pass resolution and record minutes in the registers.

c) The Headmasters and Parents Committee shall monitor the cleaning of the toilets daily and the sanitary workers should be asked to clean toilets minimum thrice in a day.

 d) If the performance of sanitary workers is not good, the Parents committees can discuss and remove the non performing person(s) after passing resolution and recording minutes and can engage other suitable person(s)
