Read the following:-

2. From the Commissioner & Director of School Education, A.P. Hyderabad, Lr.Rc.No.270/MDM-1/2010, dated 08.10.2010 and dated 06.12.2010.

ORDER:-

The Government of India, Ministry of Human Resources Development, Department of School Education an Literacy (MDM Division), in the reference first read above has informed that as per the Mid-day Meal Scheme 2006,Annexure-8, a Steering-cum-Monitoring Committee (SMC) would set up at the State, District and Block level to oversee the implementation of Mid-day Meal Scheme. The Government of India has specified the functions of the Steering cum Monitoring Committee (SMC) as follows:

- a. Guide the various implementation agencies.
 - b. Monitor programme implementation, assess its impact and take corrective steps,
 - c. Take action on reports of independent monitoring/evaluation agencies.
 - d. Effect coordination and convergence among concerned departments, agencies (eg.FCI) and schemes and
 - e. Mobilize community support and promoting public-private partnership for the programme.
2. For monitoring the Mid-day Meal Scheme effectively, the Government of India, Ministry of Human Resource Development, Department of School Education & Literacy, New Delhi, has requested the Government to take the following action:
- a. Steering cum-Monitoring Committee shall be set up, if not done already, at the State, District, City and block Level.
 - b. Meeting of SMC at Block and city level shall be held every month in the first week of the month to monitor the implementation of the scheme in the previous month and arrangements for properly implementing the scheme in every school of that particular block, particularly the availability of foodgrains and funds.
 - c. Meeting of SMC at District level shall be held every month, in which the review of the SMCs meeting held at Block level would be done in addition to the normal functions of SMC. This meeting may be held on the same date along with the meeting held every month for monitoring the lifting of foodgrains from the FCI godowns and payment made to them.

d.Meeting of SMC at State level shall be held in atleast every six months in which the review of the SMCs meetings held at District level would be done in addition to the normal functions of SMC.

3. The Government of India has finally requested the Government to issue necessary instructions in the light of the guidelines of the Mid-day Meal Scheme, 2006.

4. In the reference second read above, the Commissioner & Director of School Education, A.P. Hyderabad, while sending the proposal for constituting the Steering cum Monitoring Committee at State, District & Mandal Level and requested necessary orders in the matter.

5. After careful examination of the matter in the light of the guidelines of the Mid-day Meal Scheme, 2006, Government hereby order to constitute for setting up of Steering cum Monitoring Committee (SMC) with the following members at the State, District and Block Level to oversee the implementation of Mid-day Meal Scheme:-
